### AFMA Prime Banks Re-confirmed

The Australian Financial Markets Association today announced the conclusion of its 2012 Prime Bank Survey and the re-election of the existing AFMA Prime Banks, effective immediately. The AFMA Prime Banks are:

- Commonwealth Bank of Australia
- National Australia Bank Limited
- Westpac Banking Corporation

Prime Banks issue short-term securities (Bank Accepted Bills/Negotiable Certificates of Deposit) as part of their liquidity and balance sheet management activities. These Prime Bank securities are recognised as being of the highest quality with regard to liquidity, credit and consistency of relative yield.

The AFMA Prime Bank survey is conducted annually.
